Addressing the just concluded Commonwealth Heads of Government Meeting in Rwanda, the Commonwealth Secretary-General had this to say: 'The economic damage of Covid, and mounting debt, confronts us all. The rapid intensification of climate change poses an existential danger. The tremors of conflict and instability in our world...and economic uncertainty threaten a serious and protracted crisis'.

In spite of easing of Covid restrictions in most parts of the world, the road to economic recovery remains bumpy, if not uncertain. But one thing is indisputable: the strategies put in place by countries towards domestic resource mobilisation will play a key role in the recovery process. The need to strengthen tax administration underpins the new CATA Strategic Plan 2022-2025 which comes into effect from 1<sup>st</sup> of July 2022.

This has ensured that the Plan speaks to the pressing needs of the members and remains relevant in addressing their concerns. # Belize and Cameroon ratify the Multilateral Convention on BEPS






The OECD announced the deposit of instrument of ratification of the Multilateral Convention to Implement Tax Treaty Related Measures to Prevent Base Erosion and Profit Shifting (MLI) by Belize and Cameroon. The Convention will enter into force on 1st August 2022 for the jurisdictions.
